The first pay period of the month for all employees will begin on the $1^{\text {st }}$, end the $15^{\text {th }}$, and will be paid on the $25^{\text {th. }}$ The second pay period of the month will begin on the $16^{\text {th }}$, end the last day of the month and will be paid on the 10 th. All employees are required to submit timesheets twice a month through Kronos.

The 'Blackout Dates' listed below indicate short time frames where new hiring and/or changes to existing employees (pay rate changes, category reappointments, etc..) will be put on hold. This will always occur 2-3 business days after the Timesheets Due dates to allow for Payroll processing. Any HR Actions submitting during these dates will be placed on hold until after that short period, to be processed in the following payroll cycle.
